1. Reference is made to announcement of the Company dated 27 April 2020 and 11 May 2020 respectively (the "Announcements"). Unless otherwise defined, capitalised terms used herein have the same meanings as defined in the Announcements. On 27 April 2020, (after trading hours), the Subscriber entered into the Subscription Agreement with the Company pursuant to which the Company agreed to issue, and the Subscribers agreed to subscribe for the Convertible Notes with a principal amount of HK\$40,000,000, subject to the terms and conditions of the Subscription Agreement. Based on the Conversion Price of HK\$0.331 per Conversion Share, a maximum of 120,845,921 Conversion Shares shall be allotted and issued by the Company upon exercise in full of the conversion rights attached to the Convertible Notes. On 11 May 2020, the Convertible Notes with a total principal amount of HK\$40,000,000 have been successfully issued to the Subscriber.

2. Unless otherwise defined, capitalised terms used herein have the same meanings as defined in the announcement of the Company dated 2 May 2017 and 11 May 2017 respectively. On 11 May 2020, pursuant to the terms and conditions of the Convertible Notes issued on 11 May 2017 with a total principal amount of HK\$80,000,000, the Company has redeemed at 100% of the principal amount of such Convertible Notes together with any accrued but unpaid interest of such Convertible Notes in full.
