Remarks:

1. Reference is made to announcement of the Company dated 8 May 2023 and 16 May 2023 respectively (the "Announcements"). Unless otherwise defined, capitalised terms used herein have the same meanings as defined in the Announcements. On 8 May 2023, (after trading hours), the Subscriber entered into the Subscription Agreement with the Company pursuant to which the Company agreed to issue, and the Subscribers agreed to subscribe for the Convertible Notes with a principal amount of HK\$9,000,000, subject to the terms and conditions of the Subscription Agreement. Based on the Conversion Price of HK\$0.081 per Conversion Share, a maximum of 111,111,111 Conversion Shares shall be allotted and issued by the Company upon exercise in full of the conversion rights attached to the Convertible Notes. On 16 May 2023, the Convertible Notes with a total principal amount of HK\$9,000,000 have been successfully issued to the Subscriber.
